Progress to Strengthen the Juvenile Justice and Delinquency Prevention Act

This month the <u>Supporting Youth Opportunity and Preventing Delinquency Act of 2016</u> (H.R. 5963) — a critically important and long overdue update of the major Juvenile Justice law — was passed by the U.S. House of Representatives. The bipartisan bill includes key federal protections for justice-involved youths including a prohibition on incarceration for status offenses, requirements for removal of youths from adult jails and lock-ups and requirements to address the disproportionate number of youths of color in contact with the juvenile justice system. The bill includes new tools to prevent delinquency, curb gang involvement, and keep more youths home. The bill also bans the shackling of pregnant girls and takes steps to improve educational outcomes for detained youths. When the Senate returns after the elections, it must approve the Senate's bipartisan reauthorization bill which includes similar protections will be waiting for action.
