CJI Staff presented at Lunch and Learn in LaPorte, IN about DMC at IYI Youth Café. Comprised of different professional backgrounds; overall climate of audience and community good; accepting of information shared
- **Mental Health**
Attended today's Organization Day at the Statehouse (NAMI) Will be focusing on two policies this upcoming legislative session. Will provide position statements to share with students of IUSSWK.
Policy 1: CIT Crisis Intervention Team = 40+ hours for Law Enforcement to deescalate offender with mental health issue
Policy 2: Hoosier Alliance for Serious Illness Exemption = suffering from illness at time of crime = no time sentenced to death for it.
27/30 Youth Mental Health First Aid trainings have been arranged – few more spots available for schools across the state to take advantage. Will be sending list of existing schools to cross reference with schools in other areas that possible collaboration could be granted.
